Changes to tax offices and tax payment in 2013

On 1st January 2013, 14 new tax offices with regional competences shall be established in connection with the reorganisation of Czech tax administration. The present tax offices shall become local branch offices of their respective regional offices. The Specialized tax office shall remain unchanged.

From this date, all tax offices shall acquire new powers. Among other things, they shall be in charge of the administration and collection of premiums for pension savings.

In general, the administration of tax payments shall fall under the competence of the respective local branch office (the taxpayer's tax administrator until 31th December 2012). The only exception is the jurisdiction for real estate tax, which shall be changed and concentrated into one local branch tax office for the entire region.

One consequence is that from 1st January 2013 the bank account numbers for tax payments shall be changed as follows:

- the prefix determining the type of tax shall remain unchanged
- the new central part of the account number shall be set by the regional tax office
- the bank code of ČNB 0710 (after the slash) shall remain unchanged.
